Pursuant to the approval of the shareholders under section 81 (1A) of the Companies Act, 1956, at the Extraordinary General Meeting held on March 25, 2011, the Company allotted 17,51,290, 10\% Optionally Convertible Debentures of the face value of Rs. 100/- ("OCDs") each, to Kingfisher Finvest India Limited, one of the promoters of the Company on preferential basis.
3. The Company, on March 31, 2011, allotted 6,05,000 equity shares of Rs.10/- each, to Kingfisher Finvest India Limited, pursuant to the conversion of $8,12,031$, OCDs, at a conversion price of Rs.134.22 per equity share, in accordance with the SEBI Regulations. Consequently, the paid up share capital of the Company stands increased to Rs.12,74,92,810 divided into 1,27,49,281 equity shares of Rs.10/- each.
4. A limited review of the above financial results has been carried out by the Statutory Auditors of the Company.
5. The above financial results were reviewed by the Audit Committee and taken on record by the Board of Directors at their meeting held on April 28, 2011.
